The Council's observations in respect of this application are as follows: -

The farm and field in question is in the AONB. The shed / feed store if approved should be located in a less visible position – in the corner of the same field nearer to the main farm. This would offer access from their own land rather than a narrow lane. This particular lane is heavily used and suffers from lots of parked cars due to its close proximity to the pub and local car garage. The alternative position much nearer to the main farm offers greater security for the machinery, especially in light of the recent thefts in the area.

If approved the shed / feed store should remain ancillary to the main dwelling.

This is an agricultural shed / feed store. If approved there should be no change of use in the future to a residential dwelling.

If approved there should be no hard standing around it – as stated in the application.

It appears in the application that the relocated shed / feed store has increased in size with no corresponding explanation.

If approved the trees planted should be mature saplings between 2-5 years old. This would increase survival chances. If the shed / feed store is located nearer to the main farm it would make watering of the trees an easier process.
